The Child Development Associate (CDA) is a nationally recognized credentialing program offering educational opportunity for individuals in the early childhood care and education field to expand their knowledge, understanding, and teaching practices to connect knowledge with experience: to use what they know to inform what they do. The competency-based credential is awarded to individuals who work with young children, both as Family Child Care Providers or center-based staff, and have met all of the requirements outlined by the Council for Early Childhood Professional Recognition. The State of New Jersey, Department of Children and Families (licensing agency) recognizes the credential as equivalent to the Group Teacher Certificate.

#### How Do I Qualify to be a CDA Candidate?

- $\ensuremath{\square}$  Must have access to, and be able to use computers and laptops efficiently.
- $\ \square$  Must be at least 18 years of age.
- ☐ Must have an original (copies will not be accepted) High School diploma or GED.
- $\ \square$  Must have at least 480 hours of experience working with young children, within the past three years.
- ☐ Must have a minimum of 120 clock hours of formal child care training, which we provide through the CDA classes.
- ☐ Must be able to speak, read, and write well enough to fulfill the requirements of a CDA candidate.

#### Where and when can I get CDA Training?

A 10 month CDA program is being offered. Participants can obtain 135 hours of formal training.
